### Jon Kranov

I have an interest in becoming a board member of the Round Lake Property Owners Association. This has been done in conjunction with the DNR and aqua vegetation biologists.

My 3 primary objectives within this role are: 1) Protect the fishery by researching and documenting all species and their habitat. 2) Ensure we are "looking ahead" planning properly through things like stocking programs and habitat management. 3) Provide as much conservation education as possible to our home owners and their families on the importance of keeping our fish healthy through sound environmental stewardship.
